RAGGING IS ANTISOCIAL

BAN ON RAGGING IN THE COLLEGE

Ragging in any form at any place on the Campus or outside, especially in Hostels is strictly prohibited. Anyone reported to be involved in an act of ragging will meet strict disciplinary action leading to expulsion from the hostel and/or the rolls of the Department/Institute/College concerned.

An act of ragging will mean any of the following :-

- to address seniors as 'Sir;'
- to perform mass drills;
- to copy class notes for the seniors;
- to serve various errands;
- to do menial jobs for the seniors;
- to ask/answer vulgar questions;
- to look at pornographic pictures to 'Shock' the fresher out of their innocence;
- to force to drink alcohol, scalding tea, etc.;
- to force to do acts which can lead to physical injury/mental torture or death;
- to force to do acts with sexual overtones, including homosexual acts;
- to strip, kiss, etc.;
- to do other obscenities.

Supreme courts of India in its verdict dated 16.05.2007 on petitions for Special Leave to Appeal (Civil) Nos. 24295 & 24296-99 of 2004 from the judgment and order dated 24.06.2004 in WP No. 30845/2003 of the High Court of Kerala at Ernakulam University of Kerala etc. VS The Council, Principals', Kerala & others, has issued certain directions to the Educational Institutions for information and necessary compliance and ordered that the recommendation of the committee constituted pursuant to the Court's order to suggest remedial measures to tackle with the problem of ragging in educational institutions, should be implemented without any further lapse of time.

Punishment may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding scholarship or other benefits (ii) suspension or expulsion from Hostel or Mess and the like. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

1. As per directions of the apex court the punishment to be meted out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
2. Every single incident of ragging where the victim or his parent/guardian or the Head of Institution is not satisfied with the institutional arrangement for action, a First Information Report must be filed without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority or negligence or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the institutional authority. If any victim or his parent/guardian of ragging intends to file FIR directly with the police, that will not absolve the institutional authority from the requirement of filling the FIR.
3. Courts shall make an effort to ensure that cases involving ragging are taken up on as priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness.
4. It is clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
